## NOTICE OF APPOINTMENT OF CARETAKER COMMITTEE FOR NBA DEGEMA BRANCH

*Whereas* the election of members of the Executive Committee for Nigerian Bar Association, Degema Branch cannot be held today, Thursday, 13 June 2024 as earlier scheduled, in view of the pending petition before the Branch Election Appeal Committee (East),

*Whereas* the tenure of the Branch Executive Committee, led by Mr Victor V. Amachree expires today, 13 June 2024,

*Whereas* the inability to conduct the Branch election before the expiration of the tenure of the said Executive Committee will create a vacancy in the leadership of the Branch,

**AND** there being a need to avoid any vacuum in the leadership of the Branch, forestall a breakdown of order, ensure compliance with the provisions of the NBA Constitution and the Uniform Byelaws for Branches, and guarantee peaceful transition,

**I, hereby appoint a Caretaker Committee for Degema Branch,** comprising the following:

- 2) Ibigote Destiny Fynn – **Secretary**
- 3) Owunari Taylor-Harry – **Member**

The Caretaker Committee shall administer the affairs of the Branch beginning from today, 13 June 2023, and shall immediately conduct or supervise the conduct of the Branch election following the decision of the Branch Election Appeal Committee (East) on the pending petition(s). The said election shall be conducted, and the new EXCO sworn-in, on or before 28 June 2024.

I hereby direct the Chairman, Mr Victor V. Amachree, Esq, and the members of the Executive Committee of Degema Branch, to forthwith, hand-over ALL Branch documents, monies, and properties, howsoever described, to the Caretaker Committee. The hand-over shall be completed within 5 days from today. **For avoidance of doubt the handover shall be completed on or before 17 June 2024.** Note that failure to hand over as directed herein shall amount to gross misconduct and liable to be reported to the Legal Practitioners Disciplinary Committee (LPDC).


